## Authorization for Payment of Fees - Electronic Bank Draft or Credit/Debit Card

I authorize King's Grant Golf Club and the financial institution or credit card company named above to deduct the amount of my monthly fee from the account identified above. I understand my automatic payment will be deducted on the <u>first day of each month.</u> (except in the case of yearly payments) Changes in bank account or credit card information must be submitted by completing a new Membership application form and filling out the payment information section. Changes must be received by the 15th day of the month prior in order to be processed for next month's payment. Cancelling a bank draft or credit card does not cancel a membership. In the event that a bank draft is revoked or an account is closed and new bank or credit card information is not received, the membership will be transferred to the "annual payment" option and the remaining amount due under the terms of the Contract will be owed. Account balances due to the Club shall be payable no later than 15 days following the statement date. If any payment is not received within 90 days of the due date, the applicant hereby authorizes the Club to charge the amount due, plus any applicable fees or penalties, to the credit card listed on the account. Early termination will only be accepted in the event of a member who passes away or a member who has accepted a military assignment out of the area. A \$30.00 return fee will be charged for each returned bank draft or declined credit card (i.e. Revocations, Closed Accounts, & Non-Sufficient Funds).

#### I agree to abide by the following:

I agree to abide by all rules, regulations and bylaws of King's Grant Golf Club. I understand and agree that this membership will begin on the date that this Contract is signed and will run continuously, renewing on an annual basis, until a cancellation form is filled out and submitted by the Member or notice of cancellation is mailed by King's Grant Golf Club. I understand that this membership will automatically renew for all subsequent years unless cancelled pursuant to this agreement. I also understand that management reserves the right to increase the fees for subsequent membership terms by notifying me in writing 30 days prior to the start of the new membership term at my last known address or email. I further understand that the initiation fee is a non-transferable, non-refundable fee. I understand that in the event of a default of this Membership Agreement by the Member, King's Grant Golf Club shall have the option to revoke my membership and all rights and privileges of King's Grant Golf Club with no refund of any amount previously paid. Member hereby agrees that no formal notice of default shall be required even if the nature of the default relates to failure to pay monthly dues, fees, charges, or any violation of King's Grant Golf Club rules and regulations.

Memberships may be cancelled by the member by completing a Cancellation Form available at King's Grant Golf Club and will be honored under the following terms: The membership is for a one-year mandatory period and automatically renews for another one-year period unless a Cancellation Form is completed and received within 30 days of the start of next membership renewal (i.e. the start of the following year in an annual membership). If a member chooses to cancel their contract before the end of the one-year membership period, whether under a monthly or annual payment agreement, they will be subject to pay a \$250 early cancellation fee. Your membership contract will remain valid until a Cancellation Form is completed or notice of cancellation is mailed or e-mailed by King's Grant Golf Club. #### Waiver/Release

There is no guarantee as to the condition of the course or any amenity included in this membership. Members will have access to amenities listed in this agreement subject to availability, which is to be determined at the sole discretion of King's Grant Golf Club. Certain private and public events may dictate that the golf course, practice areas, clubhouse and/or other areas of King's Grant Golf Club be closed. Member understands and agrees that nothing in this Membership Agreement shall entitle member to any of the facilities on any particular day nor to any discount or refund on account of any limited access. Member further understands that access to the course, practice facilities, clubhouse and other privileges and benefits may be limited by King's Grant Golf Club as necessary. No member is entitled to a refund or return of amounts due to damage to or condition of the golf course or any amenity. Further, King's Grant Golf Club shall have no liability for temporary suspension of any privilege due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions or any and all other matters beyond control of King's Grant Golf Club.
